Challenges Metro Council Action Appeal Filed in In 1st Circuit on Mall Annexation

BATON ROUGE — Capital City News editor Woody Jenkins has filed a brief with the 1st Circuit Court of Appeal challenging a ruling by District Judge Janice Clark in the Mall annexation controversy.

Jenkins filed suit in June that the Metro Council had no legal authority to annex portions of the Mall of Louisiana.

The annexation by the Council in May provided that the City of Baton Rouge would annex the smaller stores in the Mall, the hallways, and some of the parking lots. However, the largest anchor stores, such as Sears, Penney's, Dillard's, and Macy's refused to sign the annexation petition and were not included in the annexation. The result was a map showing large donut holes inside the proposed new city limits.

Jenkins said this creates an illegal and unworkable situation where Baton Rouge City Police would patrol the hallways and smaller stores, while Sheriff's deputies would have responsibility for the anchor stores. Anyone who walked through the Mall would go in and out of the City of Baton Rouge numerous times, he said.

Jenkins filed suit against the City of Baton Rouge, alleging that the East Baton Rouge Parish Plan of Government requires that annexations be of a "compact body of land." The city also failed to meet many other legal standards, Jenkins argued. In July, Judge Clark ruled that Jenkins had no standing to file the suit. However, Jenkins alleges in his appeal that the Plan of Government clearly says "any citizen" has the right to challenge an illegal annexation. The city has until Oct. 15 to file its own brief with the Court of Appeal.

Cassidy, Maness Challenge Landrieu Three-Way Battle for U.S. Senate

CENTRAL — Two Republican candidates are challenging Sen. Mary Landrieu in the Nov. 4 election, and she appears vulnerable to either.

In a CNN poll published this week, Congressman Bill Cassidy (R) was leading Landrieu 50-47, while Col. Rob Maness (R) and Landrieu were tied 48-48. The runoff, if necessary, will be Dec. 6. Former Alaska Gov. Sarah Palin was in Louisiana last Saturday to campaign for Maness.

Cassidy and Landrieu and their allies have been attacking one another on everything from veterans benefits to Obamacare to illegal immigration.

Millions have already been spent by the candidates

Both Landrieu and Maness say Cassidy is dodging televised debates, but all three will apparently participate in an LPB debate at 7 p.m. Oct. 14 and a WAFB debate Oct. 29.

Two Republicans Fight to Face Off Against Landrieu

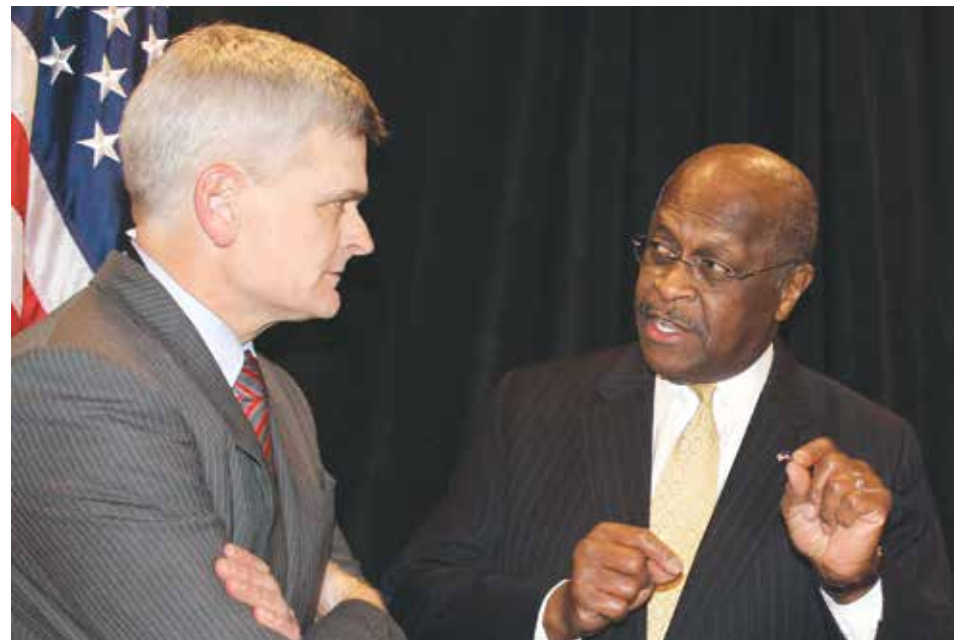

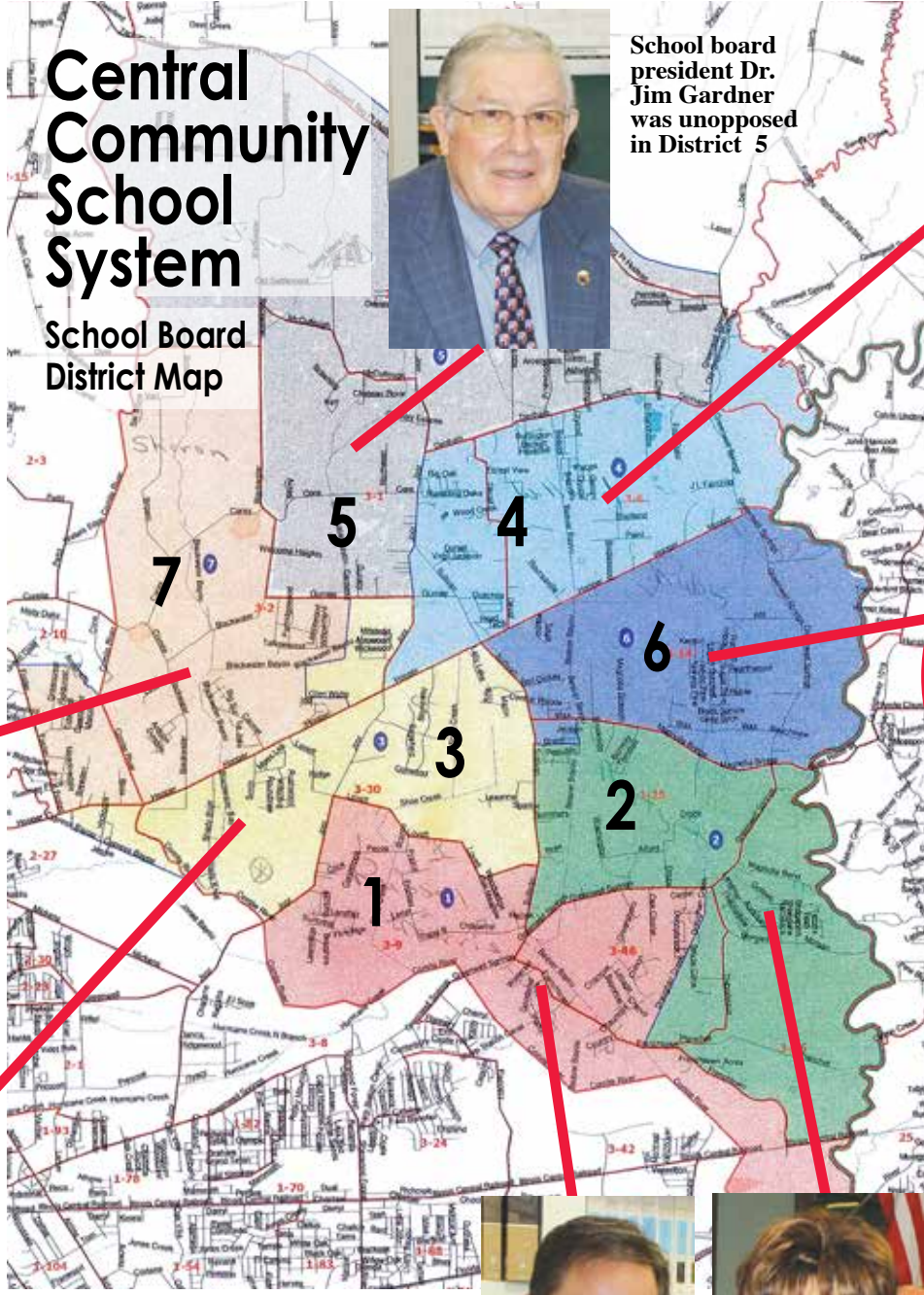

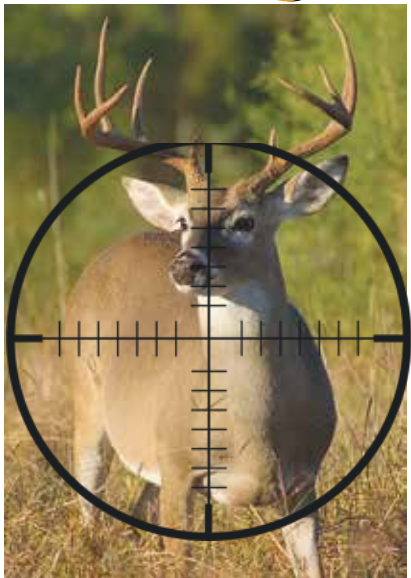

Central High Students Elect a Special Queen

Handicaps Didn't Stop CHS Student From Achieving Dream of Lifetime

CENTRAL — Life hasn't always been easy for Alyssa Hollingsworth, a Central High School senior who suffers from cerebral palsy, multiple handicaps, and a few years ago cancer. But one thing did come easy — an overwhelming victory in her election as Central High's 2014 Homecoming Queen.

She won in a landslide, receiving more than twice as many votes as her nearest competitor.

Perhaps her victory says as much about those who did the voting as it does about Alyssa. The vote was by secret ballot of the Central High School student body.

The Central Community School System is a small school system with only 4,500 students, but goes

Alyssa suffered from Grade 4 brain hemorrhaging four days after birth. "She's had a tough time," her dad said, "She's had multiple surgeries, including back surgery with steel rods inserted, scoliosis, and hip surgery. In 2002, she had cancer and was at St. Jude's for nine months. That was tough on her to be away so long."

"But she loves to be with people. She understands everything that's going on. She can't read because of her eye spasms but she enjoys TV." Asked if Alyssa can talk, her dad laughed, "Can she talk! My God, she won't stop talking! She has headsets and loves to talk with her friends on the phone."

"One of her favorite things is getting to cheer with the cheerleaders every year, but there are numerous events she participates in throughout the year. The main thing is, she likes to get out of the house."

Central High principal David Prescott said Alyssa is a precious girl. "She is so sweet, and this meant so much to her." Coach Sid Edwards, himself the father of two autistic children, said, "Isn't it great to live in a community where everybody is treated like they ought to be treated? I'm so proud of Alyssa and proud of our kids."

Craig McCulloch Looks to Replace Bill Cassidy in the 6th District

Local businessman “fed up” with politicians in Washington, DC, seeks to bring small town, conservative values to Congress

Local business owner Craig McCulloch has entered the race to succeed Rep. Bill Cassidy as Congressman from Louisiana’s Sixth Congressional district.

A graduate of Baker High School and member of the Baker football hall-of-fame, McCulloch took his athletic skills to Nicholls State University on a football scholarship where he was one of the first starting quarterbacks on their first varsity team. In 1975, he finished his pre-physical therapy schooling at Nicholls and in 1977 graduated physical therapy school at Louisiana State University.

During his breaks from school, McCulloch would work on oil platforms in South Louisiana.

“I was always at the bottom of the totem pole,” McCulloch said of the experience. “They would have me wading waste deep in the muck and sometimes it would be close to freezing outside. Without a doubt though, I can say that experience coupled with football taught me the definition of hard work and the value of a dollar.”

In 1984, Baker Physical Therapy opened its doors and McCulloch began his career as a small business owner.

“It was definitely a risk,” McCulloch said. “No one invested in me and the government definitely didn’t help start my business. We built it from the ground up. It’s a family business.”

Today, Baker Physical Therapy continues to serve residents of the Baker, Zachary, Central and Greater Baton Rouge area.



McCulloch said he made the decision to enter the race after much thought and prayer because, “we can’t afford to settle for status quo career politicians or for candidates who don’t share our values or have the life experiences necessary to help fix the mess in DC.”

“I want to preserve the American Dream for my children and grandchildren,” McCulloch said.

McCulloch says he also understands the needs of District Six’s numerous small towns.

“Career politicians seem to neglect our small towns because there are just not a lot of voters there,” McCulloch asserted. “That’s not me. I’ll fight for all of our plant workers, our farmers, our fishermen and our countless other hard-working individuals, no matter the size of your business or how many people live in your town.”



McCulloch said that passing a balanced budget amendment would avoid “government shutdown fiascos” and “endless fiscal cliffs.”

“I balance my personal and business checkbooks,” McCulloch said. “Why can’t Washington do the same? If a small business spends more than it takes in, we call it bankrupt, but Washington is allowed to just kick the can down the road and write the federal government a blank check. Enough with the special treatment for Washington, D.C. This kind of mismanagement is hurting our children’s futures.”

McCulloch said his top priorities are creating jobs, getting our fiscal house in order, and true healthcare reform.

“I’m the only candidate in this race who is in the healthcare industry,” McCulloch said. “We need real healthcare reform that is based on competition and the free market, not that rests on the backs of hard working families and individuals.”

McCulloch said another key issue facing our nation is energy security.

“The President’s war on energy is costing Louisiana residents jobs and it’s harming our national security,” McCulloch said. “We need to promote domestic drilling and encourage international exportation of energy. We will create more jobs, become energy independent, strengthen our national security, keep our kids out of harm’s way overseas and take power away from our enemies abroad.”

McCulloch is an up front advocate for term limits. “I think that’s a big part of the problem up there,” McCulloch said, “People get elected and suddenly they get starstruck and start falling in line with the Washington establishment. Political service shouldn’t be a career, that’s not what the founders had in mind.”

McCulloch describes himself as being “100 percent pro-life and a firm believer in traditional Louisiana values.”

“My view on marriage is simple: One man. One woman. Period,” McCulloch said.

“I’m a proud conservative, and not ashamed to say it,” McCulloch said. “I don’t think believing in traditional marriage is a radical view. I’m also no career politician and I haven’t been waiting to do this my whole life. I don’t have to take a poll to know my positions, and I believe in doing what is right and just being honest. Our grandma’s were right, just tell the truth and work hard, it’s what I’ve done my entire life.”
